

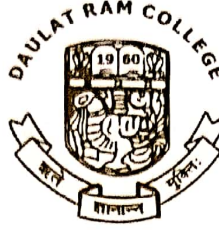

3. Nomination along with affidavit format can be downloaded from the college website <https://www.dr.du.ac.in/> w.e.f. 07-09-24. Enclosures and the nomination form should be filed in a sealed envelope and deposited in the nomination box placed in the office of the Election Officer as per the given schedule. The nomination box will be sealed at 02:30 pm on 13-09-24, in the presence of the members of SAB and representatives of each candidate who filed a nomination for Daulat Ram College Students Union Election 2024-25.
4. All candidates must read and understand the Code of Conduct for Students' Election. The Lyngdoh committee recommendations, the decision of Hon'ble Supreme Court of India regarding Students' Union Election, "University of Kerala vs Council, Principals, Colleges, Kerala and others". The order of the National Green Tribunal of July 18, 2016, Hon'ble Delhi High Court order dated 29-05-2018 in W.P.(C) 7824/2017 titled "Prashant Manchanda vs Union of India and ORS (Defacement case)" and the Delhi prevention of defacement of property act, 2007.
5. Withdrawal will be permitted only if it is submitted by the candidate in her writing in person with a copy of college identity card no. Withdrawal shall be allowed as per schedule.
