- 3. The work shall be carried out as per CPWD specifications.

- 5. The Contractor shall see the site of work before Tendering at his own cost.
- In case of error in description of any DSR item, given in the schedule, the description given in the CPWD schedule of rates shall be final and no claim on account of error shall be made.
- 7. The College reserves the right to split the works among the tenders and the decision of Principal shall be final and binding on the tenders.
- 8. The acceptance of the tender will rest with the Principal / GB Hostel Committee who does not bind itself to accept the lowest tender and reserves the right to reject any or all tenders received without assigning any reason. All tenders in which any or the prescribed conditions are not fulfilled is liable to be rejected.
- 9. This tender shall remain open for acceptance for a period of 90 days from the date of opening of tender. If any tenderer withdraws his tender before the said period or made any modifications in the terms and conditions of the tender which are not acceptable to the College then the College without pre-judice to any other right or remedy be at liberty to forfeited the Earnest Money.
