TERMS AND CONDITIONS

- 1. Sealed quotations are invited under two bid systems (Technical Bid and Financial Bid) from the experienced and established contractors empanelled with Delhi University / Delhi Govt. / Central Govt. agencies for whitewashing the college hostel building(s).
- 2. The tender document must accompany a draft of Rs. 50,000/- as earnest money in favour of the 'Principal, Daulat Ram College Hostel' payable at Delhi otherwise tender will not be accepted. No cash / cheque payment will be accepted.
- 3. The tender document must accompany a draft of Rs. 1000/- as cost of tender in favour of the 'Principal, Daulat Ram College Hostel ' payable at Delhi otherwise tender will not be accepted. No cash / cheque payment will be accepted.
- 4 . The college shall retain 10% as security money from each running bill which will be refunded after the expiry of six months towards the defect liability period from which no interest shall be paid.
- 5. The unsuccessful bidders will get their EMD returned within 10 days of opening of bids whereas the EMD of successful bidder shall be retained by the college till the work is over for which no interest shall be paid.
- 6. The college shall charge 1% towards water charges which will be deducted from the bills.
- 7. The defect liability period for the said work will be six months from the date of submitting the final bills or from the date of the execution of work to be completed whichever is later.
- 8. The rates of the tender shall be valid for one year from the date of its opening.
- 9. The acceptance of a tender will rest with the Employer who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all the tenders received without any reason. All tenders in which any of the prescribed conditions are not fulfilled and are incomplete in any respect are liable to rejection. The earnest money of all the unsuccessful bidders shall be refunded without any interest after the work is awarded.
- 10. The contractor is also required to get the brand and colour approved from the college

prior to purchasing / using the same in the college hostel.

- 11. The college shall not pay for any waste material.
- 12. The work shall be carried out to the entire satisfaction of the undersigned or any other expert nominated by the Principal for the purpose.
- 13 . For any defects, the Principal has right to reject the work at the risk and responsibility of the contractor for which no appeal will be entertained.
- 14. The decision of the Principal shall be final.
- 15. The time limit for the entire said work will be one months from the date of issue of the award letter. In case the work is delayed & not completed within the stipulated period the contractor will have to bear a penalty of Rs. 1000/- for each extra day.
- 16. No payment against the material at sight will be paid.
- 17. The place for storage of contractor's material would be provided by the employer in the college premises. However, the responsibility for watch and ward of such material will be entirely of contractor's.
- 18. The measurement for the interior/exterior painting shall not include the space adjoining the doors and windows frames.
- 19. Payment will be made in installment subject to the judicious accomplishment of work.
- 20. The college will have the right to deduct any amount from the security of the contractor on account of damage done to the college building by the Contractor at the time of doing the work.
- 21. The work would include scraping the existing white wash / removal/clearing of all furniture, movable fittings / fixtures, equipment / appliances etc. from the site of whitewashing and covering of all immovable articles to avoid lime-stains / paint on those.
- 22. Clearing of surfaces from dust, cobwebs, etc and smoothening of uneven portions of surfaces by proper scraping and refilling those with Plaster of Paris before whitewashing / painting is done.
- 23. The contractor shall make his own arrangements for electrification, if needed, the college Hostel would provide only points for electric supply.
- 23. The contractor has to clean all the window panels / glasses, skirting, doors, and floor soon after completion of a certain portion of the building otherwise action will be taken against them.
- 25. Necessary repairs of walls, roofs and exposed bricks work will be carried out by the

contractor to the entire satisfaction of the college before white washing / OBD / colour wash / snqwcem / painting / polishing etc.
