 - c) Loans & advances given to staff has not been cleared within time limit given in GFR rules i.e. it should be cleared within 30 days as per GFR rules.
 - d) Booking of reversal of Trust Share Receivable relating to financial year 2017-19 amounting to Rs. 5,01,71,000/- during the current financial year at the discretion of Trust as the same was wrongly recognized as the income of the College in past years as per letter no.DRC/UGC/2022/485 dated 08.07.2022 provided to us.

Subject to above, the Balance Sheet and Income & Expenditure Account dealt with by this Report are in agreement with the books of account.

Management's Responsibility for the Financial Statement

Management is responsible for the preparation of these financial statements that give a true and fair view of the financial position and financial performance. This responsibility includes the design, implementation and maintenance of internal control relevant to the



preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.
