Nomination form along with affidavit format can be obtained from Ms. Trisha Pandey w.e.f 3.pm on 14th January 2023, the necessary enclosures along with the form as detailed below, should be filed in a sealed envelope and deposited in the nomination box placed at the office of election officer before 12 noon on 18th January 2023. The nomination box shall be unsealed at 2pm on 18th January 2023 in the presence of the members of the students advisory board and one Representative each of candidates for DRCSU election 2022-2023.
4. All candidates must read and understand the code of conduct for student's election. The Lyngdoh committee recommendations decision of Hon'ble supreme court of India regarding students union election "University of Kerala Council Principals Colleges, Kerala and others" the order of the National Green Tribunal of July 18, 2016, Hon'ble Delhi High Court order dated 29.05.2018 in W.P (c) no.7824/2017 titled 'Prashant Manchanda v. union of India & ORS(defacement case)"and the Delhi prevention of defacement of property act, 2007.
5. Withdrawal will be permitted only if it is submitted by the candidate in her writing and in person with copy of college identity card no withdrawal shall be allowed till 12.00 noon on 19th January 2023.

Enclosures with the Nomination Form

1. Nomination form duly filled in and signed by the candidate along with passport size photo affixed at the appropriate box.
2. Along with nomination form candidates have to sign a declaration and an undertaking regarding their eligibility and confirmation of strict adherence to the rules of elections and code of conduct of elections.

Each nomination is to be proposed and seconded by an eligible voter in writing.

4. Copy of class X examination showing the date of birth of the candidate.
5. Copy of previous year mark sheet.
6. Copy of current year college identity card.
7. Copy of current year feeslip.
8. Copy of current year (2022-2023) valid identity card of the student proposing and seconding the nomination.

Please Note- All papers/documents attached with the nomination form must be self-attested by the candidate and originals of these documents will have to be produced by the candidates for verification at the time of scrutiny of nomination forms.

Salient points of the code of conduct of elections to be noted and adhered to by all candidates and students.

1. No candidate shall indulge in, nor shall abet, any activity, which may aggravate existing differences or create mutual hatred or cause tension between different caste and communities, religious or linguistic, or between any group(s) of students.
2. All students shall be prohibited from indulging or abetting all the activities which are considered to be 'corrupt practices' and offences, such as bribing voters, intimidation of voters, and impersonation of voters.
3. No candidate should have any record of police case filed against her, prior to the date of notification of the DRCSU election 2022-2023. the candidate shall also not have been subject to any disciplinary action by the college authorities.
4. No candidate shall be permitted to make use of printed posters, printed pamphlet, or any other printed material for the purpose of canvassing.
5. No candidate shall, nor shall his/her supporters, deface or cause any destruction to any property of the university/college campus including the website and Facebook pages of university/colleges for any purpose whatsoever. All candidates shall be held jointly and severally liable for any destruction/defacing of any university/college property.
6. The use of loudspeaker, vehicle and animal for the purpose of canvassing shall be prohibited. Pasting/stapling of posters on trees in the campus shall be strictly prohibited.
7. Contravention of any of the above provisions and other provisions and code of conduct may make the candidate liable to be stripped of her candidature, or her elected post, as the case

Maybe. The college/ University authorities may also take appropriate disciplinary action against such a violator.

With this notification, the code of conduct of elections comes into operations and any violation of the same shall result in disqualification/election of the candidate countermanded and shall invite punitive action
