The Order of the National Green Tribunal of July 18, 2016, Hon'ble Delhi High Court order dated 29.05.2018 in W.P. (C) No. 7824/2017 titled "Prashant Manchanda V/S Union of India and ORS(Defacement Case)" and The Delhi Prevention of Defacement of Property Act, 2007.
