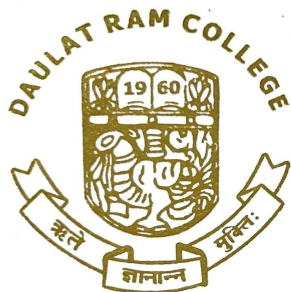
- **Gender-Based Violence: How safe are our women?**

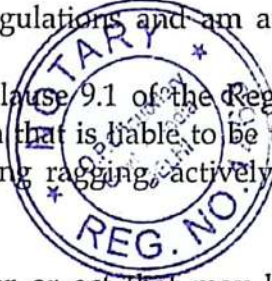

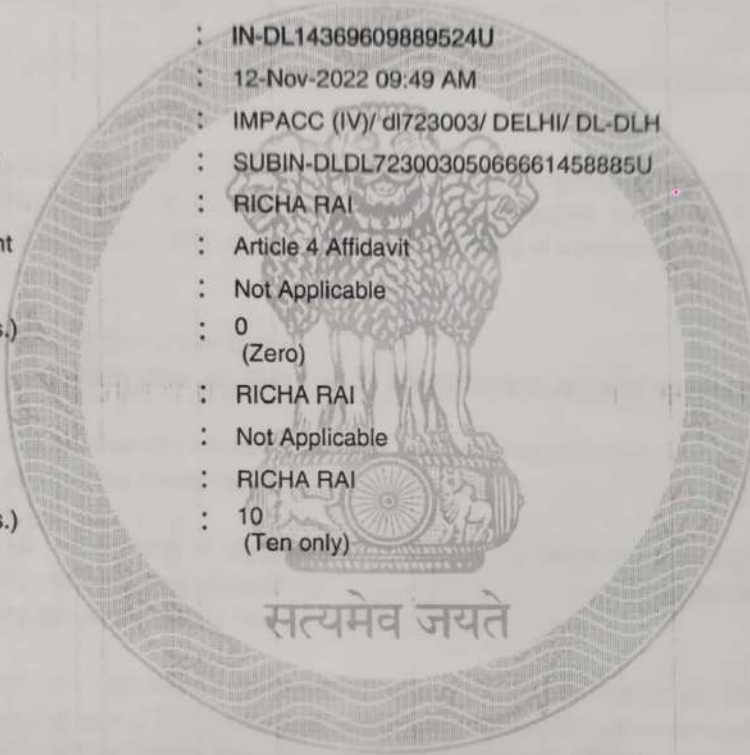

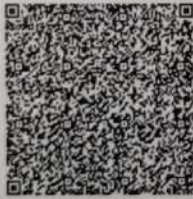
